### **DECISION ON MOTION BY PROFESSOR VOJISLAV ŠEŠELJ FOR THE DISQUALIFICATION OF JUDGES O-GON KWON AND KEVIN PARKER**

On 19 November 2010, the Chamber dismissed the accused's motion for the disqualification of Judges Kwon and Parker from the contempt proceedings against him.

*This decision was filed confidentially on 19 November but its confidentiality was lifted on 23 November 2010.*

### **ORDONNANCE PORTANT MODIFICATION DU CALENDRIER**

On 22 November 2010, the Chamber ordered the parties to submit their final trial briefs by 4 January 2011. The closing arguments will be heard from 31 January 2011 (the Prosecution will have 15 hours and each Defence team five hours to present their arguments).

### **DÉCISION PORTANT SUR LA REQUÊTE DE LA DÉFENSE PRALJAK EN RÉOUVERTURE DE SA CAUSE**

On 23 November 2010, the Chamber denied in its entirety Slobodan Praljak's request to reopen its case and tender into evidence extracts of Mladić's notebooks.

### **DÉCISION PORTANT SUR LA DEMANDE DE LA DÉFENSE PETKOVIĆ EN RÉOUVERTURE DE SA CAUSE**

On 23 November 2010, the Chamber partially granted Milivoj Petković's request to reopen its case and admitted three extracts of Mladić's notebooks into evidence.

### **DÉCISION PORTANT SUR LA REQUÊTE DE LA DÉFENSE STOJIĆ EN RÉOUVERTURE DE SA CAUSE**

On 25 November 2010, the Chamber denied in its entirety Bruno Stojić's request to reopen its case and tender new exhibits into evidence.
