**Pre-trial conference/trial**

On 28 November 2011, the parties met before the Chamber for the pre-trial conference. On 30 November 2011, the parties presented their evidence in court, without witnesses, only documents were admitted into evidence. The Chamber dismissed the Defence’s motion for acquittal pursuant to Rule 98*bis*. On 1 December 2011, the Defence made its closing arguments.

On 2 December 2011, the Chamber adopted the Prosecution’s proposal to reduce its case and ordered it to file an amended indictment within two weeks – *See Press Release number 1463, dated 2 December 2011.*
