#### MLADIĆ case

*Trial Chamber I – Judges Orić (Presiding), Moloto and Flüggé*

#### Commencement of the Prosecution case

On 16 and 17 May 2012, the Prosecution made its opening statement.

*The trial is adjourned until further notice.*

#### STANIŠIĆ & SIMATOVIĆ case

*Trial Chamber I – Judges Orić (Presiding), Picard and Gwaunza*

#### Continuation of the Defence case

On 14, 15 and 17 May 2012, the following witness testified:
