DECISION ON PRALJAK'S REQUEST FOR STAY OF PROCEEDINGS

On 27 June 2014, the Appeals Chamber instructed the Registrar to assign counsel to Slobodan Praljak in the interest of justice, denied his request for stay of proceedings and ordered him to reimburse the ICTY for the Defence costs.
