ORDER RESCHEDULING START OF TRIAL

On 27 June 2008, Trial Chamber I ordered that:

- the pre-trial Conference shall take place on 24 September 2008;
- the opening statement of the Prosecution shall take place on 1 October, followed on 2 October 2008 by the opening statement of the Defence and/or a statement of the accused pursuant to Rule 84bis, if any, at this stage of the proceedings;
- the presentation of evidence shall commence on 3 October 2008.

The Chamber revoked its previous order recalling Momčilo Perišić from provisional release issued on 18 June 2008.
