## LAST MINUTE NEWS

### JELISIC CASE:

#### **THREE ADDITIONAL WITNESSES FOR THE PROSECUTION**

On Tuesday 27 April 1999, Trial Chamber I (Judges Jorda (Presiding), Riad and Rodrigues) authorised the Prosecution to call three additional witnesses. The Decision disposes of two Prosecution Motions filed on 17 and 24 March 1999 (See Update No. 71) by which the Prosecution requested to call in total four more witnesses. However, the Trial Chamber considered that the fourth witness would testify on the same points as his brother who already appeared on the witnesses-list. It consequently asked the Prosecution to decide whom of those two witnesses will eventually testify.
