PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

MILOŠEVIĆ Case (“Croatia and Bosnia and Herzegovina”)

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

DECISION ON DEFENDANT DUŠAN FUŠTAR’S EMERGENCY MOTION SEEKING A TEMPORARY PROVISIONAL RELEASE TO ATTEND THE 40 DAY MEMORIAL OF HIS FATHER’S DEATH

On 11 July 2003, the Trial Chamber granted Dušan Fuštar’s Motion for a temporary provisional release. It ordered *inter alia* that the Accused be on provisional release between 18 July and 20 July 2003.

HADŽIHASANOVIĆ *et al.* Case (“Central Bosnia”)

Appeals Chamber – Judges Meron (Presiding), Pocar, Shahabuddeen, Hunt and Güneý

DECISION ON INTERLOCUTORY APPEAL CHALLENGING JURISDICTION IN RELATION TO COMMAND RESPONSIBILITY

On 16 July 2003, the Appeals Chamber unanimously dismissed the appeal insofar as it related to the first ground of appeal and allowed it by majority (Judge Shahabuddeen and Judge Hunt dissenting) insofar as it related to the second ground of appeal.

Judge Shahabuddeen appended a partial dissenting opinion. Judge Hunt appended a separate and partially dissenting opinion.

DECISION TO INVITE THE SPECIAL REPRESENTATIVE OF THE SECRETARY GENERAL TO SUBMIT A STATEMENT

On 16 July 2003, the Pre-Trial Judge invited Mr. Michael Steiner, the Special Representative of the Secretary-General to Kosovo, to provide to the Chamber, if he so wishes, a statement on his knowledge, if any, of facts potentially relevant for the Chamber’s assessment of the risk that the Accused would evade Justice or pose any danger to any witness, victim or other person and to do so, if possible, before 25 July 2003.
