PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

MARTIĆ Case

Trial Chamber I – Judges Moloto (Presiding), Nosworthy and Höpfel

Continuation of the Prosecution case

On 8 May 2006, the trial was adjourned because of the ill-health of the accused.

On 9 May 2006, the following witness was cross-examined by the Defence (the accused was not present):

- Witness Ari Kerkanen (former criminal intelligence analyst of the ICTY)

On 11 May 2006, Judge Moloto announced that the trial would be adjourned until 22 May 2006 at 09:00 in courtroom II due to the ill-health of the accused.

DECISION ON DEFENCE APPLICATION FOR PROVISIONAL RELEASE OF THE ACCUSED LJUBOMIR BOROVČANIN

On 10 May 2006, pursuant to Rule 65 of the Rules, Trial Chamber II denied the Defence application for provisional release of the accused Ljubomir Borovčanin, filed on 2 March 2006.

PERIŠIĆ Case

Trial Chamber III – Judges Robinson (Presiding), Kwon and Bonomy

DECISION GRANTING MOMČILO PERIŠIĆ’S MOTION TO MODIFY CONDITIONS OF PROVISIONAL RELEASE

On 11 May 2006, pursuant to Rules 65 and 54 of the Rules, Trial Chamber III granted the accused’s motion to modify conditions of his provisional release and ordered that “the accused has permission to visit his brother at 32308 Pranjani, Koštunići, Gornji Milanovac, Republic of Serbia on (i) 15-30 May 2006, (ii) 15-30 June 2006, and (iii) 15-30 July 2006.”

The motion was granted subject to certain conditions set forth in the decision.

Trial Chamber III – Judges Robinson (Presiding), Kwon and Bonomy

DECISION ON MOTION TO AMEND THE INDICTMENT

On 11 May 2006, pursuant to Rules 50 and 54 of the Rules, Trial Chamber III ordered, *inter alia*, that the Prosecution shall file, within one day of this decision, a final copy of the Second amended joinder indictment and the final copy will serve as the operative indictment in this case.

Subsequently, on 12 May 2006, the Prosecution filed the “Third amended joinder indictment”.

LUKIĆ et al. Case

Trial Chamber III – Judges Robinson (Presiding), Kwon and Bonomy

DECISION ON THE FORM OF THE INDICTMENT

On 11 May 2006, pursuant to Rules 54 and 72 of the Rules, Trial Chamber III denied Sredoje Lukić’s preliminary motion alleging defects in the form of the Second amended indictment, filed on 27 February 2006.
