Closing arguments and end of the trial

From 29 August until 31 August 2006, the parties presented their closing arguments. The Prosecution requested life imprisonment for the accused and the Defence asked that he be acquitted on all charges.

The accused Krajišnik made his statement on 31 August after which Judge Orić announced the end of the trial. The judgement will be rendered in due course.

GALIĆ Case

On 29 August 2006, the parties met before the Appeals Chamber for an appeal hearing pursuant to Rule 114 of the Rules. The appellant was present. The judgement will be rendered in due course.

On 29 August 2006, pursuant to Rule 73(B) of the Rules, Trial Chamber I granted the “Request for certification pursuant to Rule 73(B) to appeal against the Trial Chamber decision to assign counsel to the accused dated 21 August 2006”, filed by the standby counsel for Vojislav Šešelj on 25 August 2006.

On 30 August 2006, the Deputy Registrar decided to withdraw Mr Van Der Spoel’s assignment as standby counsel and assigned Mr David Hooper as counsel to the accused.

REQUEST TO THE PROSECUTOR TO MAKE PROPOSALS TO REDUCE THE SCOPE OF THE INDICTMENT

On 31 August 2006, pursuant to Rule 73(D)*bis* of the Rules, Trial Chamber I invited the Prosecutor to propose means of reducing the scope of the indictment by at least one-third by reducing the number of counts charged in the indictment and/or crime sites or incidents comprised in one or more of the charges in the indictment.
