ORDER SUSPENDING UNMIK DECISION

On 18 October 2006, the Trial Chamber granted the Prosecution motion in part and ordered, *inter alia*, that the UNMIK decision authorising R. Haradinaj to give a televised interview to Company 21-Radio Television 21 in Kosovo on 18 October 2006 at 22:30 be suspended until further notice.

ORDER REQUESTING ASSISTANCE OF UNMIK WITH CERTAIN INVESTIGATIONS

On 19 October 2006, pursuant to Rule 54 of the Rules, the Trial Chamber granted the "Confidential Defence motion for the Trial Chamber to request UNMIK's assistance in the conduct of examinations of certain remains", filed on 17 October 2006, and called upon UNMIK to provide all necessary assistance

to Haradinaj, Idriz Balaj and Lahi Brahimaj in the exhumation and examination of the 14 sets of remains in question.
