#### DECISION ON PROSECUTION'S MOTION FOR ISSUANCE OF A SUBPOENA

On 21 August 2007, pursuant to Article 29 of the Statute and Rule 54 of the Rules, Trial Chamber II granted motions by the Prosecution to issue a *subpoena ad testificandum* ordering Witness 164 and Witness 101 to appear before the Tribunal. The Trial Chamber ordered the Registry to take whatever steps are reasonably necessary to ensure that the subpoenas and orders relating to this matter are transmitted immediately to the Government of Serbia.
