#### **ORDER ON SIMATOVIĆ DEFENCE MOTION REQUESTING EXTENSION OF PROVISIONAL RELEASE DURING THE WINTER COURT RECESS**

On 5 January 2011, Judge Delvoie granted the Defence motion and ordered the extension of the provisional release of Franko Simatović until 21 January 2011.

#### **ORDONNANCE PORTANT MODIFICATION DE L'ORDONNANCE ENREGISTRÉE LE 18 NOVEMBRE 2010**

On 12 January 2011, the Chamber ordered that the expert report on the state of health of Vojislav Šešelj be submitted by 15 February 2011.

#### **REGISTRY SUBMISSION OF EXPERT REPORT REGARDING THE MLADIĆ NOTEBOOKS**

On 12 January 2011, The Registry filed the handwriting analysis report of Dr Dorijan Keržan (from Slovenia). The expert report concluded that “*all of the disputed handwriting was written by the same individual*”.

#### **DECISION ON SHORTENED FORM OF THE FOURTH AMENDED INDICTMENT**

On 14 January 2011, the Chamber ordered the Prosecution to file by 21 January 2011 the revised shortened indictment in a “clean” version and in a version in which the revisions of the fourth amended indictment are indicated by “tracking”.
