##### DECISION EN VUE DE L'ENREGISTREMENT DE LA VERSION PUBLIQUE EXPURGÉE DU RAPPORT DE L'AMICUS CURIAE AYANT ENQUÊTE SUR LES ALLÉGATIONS PAR L'ACCUSÉ D'INTIMIDATIONS DE TÉMOINS PAR L'ACCUSATION

On 26 October 2011, the Chamber ordered that a public redacted version of the report of *amicus curiae* on Šešelj's motion for contempt against a number of ICTY/OTP members be filed. The report concluded that "*amicus finds that there are not sufficient grounds to instigate proceedings under Rule 77 against any identifiable person in this case as alleged in the accused's motion and the statements and testimony submitted in support thereof.*"
