DECISION ON ACCUSED’S MOTIONS FOR SEVERANCE OF COUNT 1 AND SUSPENSION OF DEFENCE CASE

On 2 August 2013, the Chamber denied the accused’s motion to sever count 1 from the indictment but it partially granted his motion for the suspension of the proceedings. The trial will resume on 28 October 2013.

MLADIĆ case

Trial Chamber I – Judges Orić (Presiding), Flügel and Moloto

DECISION ON SECOND DEFENCE MOTION SEEKING ADJUSTMENT OF THE TRIAL SITTING SCHEDULE DUE TO THE HEALTH CONCERNS OF THE ACCUSED

On 12 July 2013 (made public on 13 August), the Chamber denied the Defence motion and found that an order to reduce the trial sitting schedule was not warranted at the moment.
