#### Sredoje LUKIĆ case

## ORDER DESIGNATING STATE IN WHICH SREDOJE LUKIĆ IS TO SERVE HIS SENTENCE

On 29 January 2013 (made public on 26 August 2013), Judge Meron decided that Sredoje Lukić would serve his sentence in Norway.

### **KARADŽIĆ case**

#### **DECISION ON ACCUSED'S MOTION TO SUBPOENA JOHN ZAMETICA**

On 27 August 2013, the Chamber granted the accused's motion and issued a subpoena against John Zametica in order to testify for the Defence in this case.

#### **DECISION ON ACCUSED'S MOTION TO DISMISS THE INDICTMENT**

On 28 August 2013, the Chamber denied the accused's motion to dismiss the indictment finding that Karadžić "would have the right to appeal the judgement to be rendered by this Chamber to a legally constituted tribunal and does not consider that there is any uncertainty in this regard."

#### **PROSECUTION'S NOTICE OF APPEAL**

On 27 August 2013, the Prosecution filed its notice of appeal against the judgement.

#### **PUBLIC REDACTED VERSION OF THE 25 JULY 2013 DECISION ON SLOBODAN PRALJAK'S MOTION FOR REVIEW OF THE REGISTRAR'S DECISION ON MEANS**

On 28 August 2013, Judge Meron found that the Registrar's decision determining that Praljak was able to fully remunerate counsel was reasonable and was made in conformity with the applicable legal provisions. However, the decision was reversed insofar as it ordered Praljak to reimburse the Tribunal. The Registrar is ordered to provide the accused with an itemization of the costs to be recovered.

#### **DECISION ON DEFENCE MOTION FOR DISQUALIFICATION OF JUDGE FREDERIK HARHOFF AND REPORT TO THE VICE-PRESIDENT**

On 28 August 2013, the Chamber upheld the Šešelj's motion for disqualification of Judge Harhoff from this case – See Press Release number 1578, dated 29 August 2013.

#### **PUBLIC REDACTED VERSION OF THE 10 JULY 2013 DECISION OF THE PRESIDENT ON EARLY RELEASE OF DRAGOLJUB OJDANIC**

On 29 August 2013, a public redacted version of the President's decision was filed granting early release to Dragoljub Ojdanić, effective 29 August 2013.
