#### **DECISION ON SREDOJE LUKIC'S MOTION SEEKING RECONSIDERATION OF THE APPEAL JUDGEMENT AND ON THE APPLICATION FOR LEAVE TO SUBMIT AN *AMICUS CURIAE* BRIEF**

On 30 August 2013, the Appeals Chamber dismissed Sredoje Lukić's motion for reconsideration of the appeals judgement.

#### **ORDER FOLLOWING DECISION OF THE PANEL TO DISQUALIFY JUDGE FREDERIK HARHOFF**

On 3 September 2013, Judge Agius stayed the assignment of another Judge to sit in the place of Judge Harhoff pending a report from the remaining judges in the Šešelj case about the resumption of the proceedings.

#### **ORDER PARTIALLY STAYING EXECUTION OF “ORDER FOLLOWING DECISION OF THE PANEL TO DISQUALIFY JUDGE FREDERIK HARHOFF”**

On 4 September 2013, Judge Agius stayed his decision from 3 September (*see above*) pending the resolutions of the two motions about the same matter, filed by the Prosecution and the remaining Judges of the Šešelj case.

### **TOLIMIR case**

*Appeals Chamber – Judges Meron (Presiding), Güney, Daqun, Khan and Tuzmukhamedov*

#### **DECISION ON TOLIMIR'S MOTION FOR VARIATION OF THE GROUNDS OF APPEAL AND AMENDMENT OF THE APPEAL BRIEF**

On 4 September 2013, the Appeals Chamber granted the appellant's motion and ordered him to file an amended notice of appeal within 5 days and the consolidated appeal brief within 20 days of the filing of this decision.
