DECISION ON KARADŽIĆ REQUESTS TO APPOINT AN *AMICUS CURIAE* PROSECUTOR TO INVESTIGATE CONTEMPT ALLEGATIONS AGAINST FORMER ICTY PROSECUTOR CARLA DEL PONTE

On 27 November 2013, Judge Moloto, the Single Judge appointed by the MICT President Meron, found that there was no reason to believe that Carla Del Ponte was in contempt of the ICTY and thus denied the accused's motion.
