**PUBLIC REDACTED VERSION OF THE 25 JULY 2014 DECISION ON APPEAL
FROM DECISION ON INDIGENCE**

On 25 July 2014 (made public on 2 December 2014), the Appeals Chamber dismissed the appeal by Radovan Karadžić in relation to the financing of his Defence. The accused will therefore have to contribute 146,501 euros to the cost of his defence before the ICTY.
