#### DECISION ON DEFENCE REQUEST TO ADOPT MODALITY FOR PROSECUTION RE-OPENING

On 27 March 2015, the Chamber granted in part the Mladić Defence request to adjourn the trial in order to prepare for the Prosecution's reopening of its case (Tomašica evidence) and ordered that there would be no court hearings between 22 May and 22 June, when the reopening is scheduled to commence. Furthermore, the week of 20 July will be a non-sitting week whereas the trial will sit during the week of 10 August 2015. The Chamber will decide about the time to be allocated to the Prosecution for its reopening in due course.
