*Appeals Chamber – Judges Pocar (Presiding), Shahabuddeen, Güney, Vaz and Meron*

### **Evidentiary hearing**

#### **DECISION ON ACCUSED MOTION TO REJECT PROSECUTION MOTION TO AMEND THE FIRST AMENDED INDICTMENT**

On 5 November 2008, Trial Chamber III denied a motion by the accused to reject the Prosecution's request to amend the first amended indictment.
