#### I. OVERVIEW OF COURT PROCEEDINGS:

##### **MILOŠEVIĆ Case (“Croatia and Bosnia and Herzegovina”)**

---

*Trial Chamber III – Judges May (Presiding), Robinson and Kwon*

29<sup>th</sup> week of the Prosecution case.

From 2 June until 6 June 2003, the following witnesses were examined by the Prosecution and subsequently cross-examined by the Accused and one of the *Amici Curiae*:

- Protected Witness B-1455 (not cross-examined by the *Amici Curiae*)
- Protected Witness B-1098
- Protected Witness C-47
- Protected Witness B-24

On 3 June 2003, the Trial Chamber convened for a hearing regarding the Prosecution’s application pursuant to Rule 54 *bis* of the Rules of Procedure and Evidence. Representatives of the Government of Serbia and Montenegro participated in the hearing.

##### **SIMATOVIĆ Case**

*Pre-Trial Judge Kwon*

On 2 June 2003, the parties appeared before the Pre-Trial Judge for the initial appearance of the Accused pursuant to Rule 62 of the Rules of Procedure and Evidence. Franko Simatović pleaded “not guilty” to all the counts of the Indictment.

**DECISION ON PRELIMINARY MOTION AGAINST THE AMENDED INDICTMENT**

On 2 June 2003, the Trial Chamber granted the Defence Preliminary Motion against the Corrected Amended Indictment of 17 March 2003 in part. It further ordered the Prosecution to file a new Amended Indictment clarifying the inconsistencies in paragraphs 42-44 of the Indictment.

**DECISION ON PROVISIONAL RELEASE**

On 3 June 2003, the Trial Chamber denied Milan Milutinović’s Motion for Provisional Release filed confidentially on 23 January 2003.

*Appeals Chamber – Judges Meron (Presiding), Pocar, Shahabuddeen, Güney and El Mahdi*

**DECISION ON INTERLOCUTORY APPEAL CONCERNING LEGALITY OF ARREST**

On 5 June 2003, the Appeals Chamber dismissed Dragan Nikolić’s Appeal against Trial Chamber II’s Decision on the legality of his arrest by the Stabilisation Force (“SFOR”) of 9 October 2003.
