**CONCERNING ALLEGATIONS AGAINST MILKA MAGLOV**

**DECISION ON MOTION BY *AMICUS CURIAE* PROSECUTOR TO AMEND ALLEGATIONS OF CONTEMPT OF THE TRIBUNAL**

On 6 February 2004, the Trial Chamber ordered the *amicus curiae* to prosecute Milka Maglov for:

1. Intimidating, or otherwise interfering with, the Witness, pursuant to Rule 77(A)(iv); or alternatively,
2. Attempting to intimidate, or otherwise interfere with, the Witness, pursuant to Rule 77(B); and
3. Disclosing the identity and whereabouts of the Witness to a member of the public, in violation of an order of the Trial Chamber, pursuant to Rule 77(A)(ii).
