PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

POPOVIĆ et al. Case (“Srebrenica”)

Trial Chamber II - Judges Agius (Presiding), Kwon, Prost and Støle (Reserve Judge)

Continuation of the Prosecution case

SCHEDULING ORDER

On 22 May 2007, pursuant to Rules 54 and 73*bis* of the Rules, the Trial Chamber ordered that the pre-trial Conference shall take place on 2 July 2007 and the opening statement of the Prosecution shall take place on 9 July 2007.

Trial Chamber III - Judges Bonomy (Presiding), Chowhan, Kamenova and Nosworthy (Reserve Judge)

DECISION ON JOINT DEFENCE MOTION TO POSTPONE TRIAL SCHEDULE

On 23 May 2007, pursuant to Articles 20 and 21 of the Statute and Rules 54, 65*ter* and 73*ter* of the Rules, the Trial Chamber granted a Defence motion in part and ordered that the pre-Defence Conference shall take place on 22 June 2007 and the Defence case shall commence on 6 August 2007.

A day before, on 22 May 2007, the Trial Chamber dismissed motions for provisional release during the upcoming court recess for all six accused.

DECISION REGARDING REGISTRY SUBMISSION OF 18 MAY 2007

On 25 May 2007, the Appeals Chamber clarified that the Tribunal is to bear the cost of the appointment of *amicus curiae* and modified the timetable from the previous decision, such that Mr Nicholls, should he become *amicus curiae*, shall have two weeks from today to file a new notice of appeal and/or response brief.
