PROCEDURAL DEVELOPMENTS

DECISION ON MOTION FOR REFERRAL OF CASE PURSUANT TO RULE 11*bis*

On 9 July 2007, the Referral Bench denied the Prosecution motion for referral of the case to Bosnia and Herzegovina.

DECISION ON MILAN LUKIĆ'S APPEAL REGARDING REFERRAL

On 11 July 2007, the Appeals Chamber granted an appeal by Milan Lukić, reversed the decision to refer the case to BiH and instructed the Trial Chamber to proceed with the trial before the ICTY.

GOTOVINA et al. Case

Trial Chamber I – Judges Orić (Presiding), Van den Wyngaert and Moloto

DECISION ON DEFENDANT MLADEN MARKAČ'S MOTION FOR CLARIFICATION OF THE CONDITIONS ATTACHED TO HIS PROVISIONAL RELEASE

On 12 July 2007, the Trial Chamber varied provisional release conditions (a)(i) and (a)(ix) so as to release Mladen Markač from complying with these conditions within the limits strictly necessary to fulfil his legal duty to appear and testify at the trial against Rahim Ademi and Mirko Norac in Zagreb.

The Chamber also ordered that in all other respects the conditions applicable to the provisional release of Mladen Markač shall remain as ordered in the Appeals Chamber decision.
