PROSECUTION'S FINAL PRE-TRIAL BRIEF AND CORRIGENDUM TO FINAL PRE-TRIAL BRIEF

On 31 July 2007, the Prosecution filed the public version of its final pre-trial brief.

DECISION ON THE FINANCING THE DEFENCE OF THE ACCUSED

On 30 July 2007, pursuant to Article 21 of the Statute and Rules 44 and 45 of the Rules, pre-trial Judge Antonetti partially granted Šešelj's motion for the financing of his defence and ordered the Registry:

- to implement immediately, in respect of the accused, the procedures applicable to the provision of legal aid in accordance with the Rules and the Directive as detailed in this decision;
- to inform, without delay, the pre-trial Judge of the effective implementation of the facilities granted to the accused.

Furthermore, the order urged the accused to provide the Registry with all the useful information to assess his state of indigence and the requisite qualifications of his associates.
