**THIS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the “Order Assigning Motions to a Trial Chamber” issued confidentially and *ex parte* by the President of the Tribunal on 13 March 2009, assigning this Chamber to consider the “Prosecution’s Motion under Rule 77 Concerning Further Breaches of Protective Measures” filed confidentially and *ex parte* before Trial Chamber III on 26 January 2009 in the case of *Prosecutor v. Vojislav Šešelj*;

**NOTING** the Order in Lieu of an Indictment issued on 3 February 2010 against Vojislav Šešelj (“Accused”) on one count of contempt of the Tribunal, punishable under Rule 77(A)(ii) of the Rules of Procedure and Evidence of the Tribunal (“Rules”), for having disclosed information which may identify 11 protected witnesses in violation of orders of a Chamber in a book;

**NOTING** that the initial appearance of the Accused was held on 29 April 2010 and that the trial proceedings in the present case were conducted on 22 February 2011 and between 6 and 8 June 2011;

**NOTING** that the Chamber thereafter withdrew for deliberations pursuant to Rule 87(A);

**PURSUANT TO** Rule 98 *ter*;

**HEREBY ORDERS** that the Judgement in the present case shall be delivered on 31 October 2011 at 8.00 a.m. in Courtroom I.
