**THE REFERRAL BENCH** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**BEING SEIZED OF** the “Urgent Motion by the Prosecutor for Referral of the Indictment Pursuant to Rule 11*bis*” (“Motion”), filed by the Office of the Prosecutor (“Prosecution”) on 5 July 2007, requesting that the Referral Bench order the referral of the present case under Rule 11*bis* of the Rules of Procedure and Evidence (“Rules”) to the authorities of Bosnia and Herzegovina;

**NOTING** the “Order Appointing a Referral Bench”, issued by the President of the Tribunal on 6 July 2007;

**NOTING** that Trial Chamber I in a Decision issued on 5 July 2007 considered as inappropriate and denied the “Prosecution Motion for Suspension of the Commencement of Trial and All Related Proceedings” of the same date;<sup>1</sup>

**CONSIDERING** that the trial in the present case is due to commence on Monday 9 July 2007;


**CONSIDERING** that the extraordinary circumstances in which the Motion to the Referral Bench was filed warrant the conduct of an emergency hearing without delay;
