NOTING the “Second Decision on Joint Defence Motion to Strike the Prosecution’s Further Clarification of Identity of Victims” (“Impugned Decision”) rendered by Trial Chamber I (“Trial Chamber”) on 2 March 2009;

NOTING the “Decision on Joint Defence Request for Certificate to Appeal the Second Decision on Joint Defence Motion to Strike the Prosecution’s Further Clarification of Identity of Victims”, issued by Trial Chamber I on 19 March 2009, granting Counsel for Ante Gotovina, Ivan Čermak and Mladen Markač (“Defence”) certification to appeal the Impugned Decision;

NOTING the “Joint Defence Appeal Against Second Decision on Joint Defence Motion to Strike the Prosecution’s Further Clarification of Identity of Victims”, filed by the Defence on 30 March 2009;

CONSIDERING Articles 12(3), 14(2) and 21(4)(a) of the Statute of the International Tribunal;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal as set out in document IT/261 issued on 17 November 2008;
