ORDER SCHEDULING A STATUS CONFERENCE

I, BAKONE JUSTICE MOLOTO, Judge of Trial Chamber I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING Rule 65*bis*(A) of the Rules of Procedure and Evidence (“Rules”), which states that “A Trial Chamber or Trial Chamber Judge shall convene a status conference within one hundred and twenty days of the initial appearance of the accused and thereafter within one hundred and twenty days after the last status conference”;

CONSIDERING that the last Status Conference was held on 3 April 2007;

NOTING that the Accused Mladen Markač (“Markač”) and Ivan Čermak (“Čermak”) are on provisional release in the Republic of Croatia pursuant to Rule 65 of the Rules;¹


NOTING that neither the Statute nor the Rules prohibit the making of an appearance by video-conference-link;

PURSUANT to Rules 54 and 65*bis*(A) of the Rules;

HEREBY ORDER THAT

- (i) a status conference takes place on Friday 6 July, 2007, at 1500 hours in Courtroom 1;
- (ii) the Accused Ante Gotovina and counsel to attend in person; and
- (iii) the Registry to make all necessary arrangements in order to enable the Accused Markač and Čermak to appear before the Trial Chamber via video-conference link from an appropriate location in Zagreb, Republic of Croatia.
