Knoops as Legal Consultant **THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "International Tribunal", respectively);

RECALLING that during the last status conference on 14 July 2010, the Pre-Appeal Judge stated that he and the parties had agreed that the appeal hearing in the present case would be held on 21 September 2010 ("Appeal Hearing") and that the Appeals Chamber would in due course formally set the date for the Appeal Hearing and determine the pleadings time allotted to Counsel; ¹

NOTING that Rule 114 of the Rules of Procedure and Evidence of the International Tribunal ("Rules") provides that "[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties";
