TRIAL CHAMBER III ("Trial Chamber") of the International Tribunal for the Prosecution of

Persons Responsible for Serious Violations of International Humanitarian Law Committed in the

Territory of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED of "Milan Lukić's Motion for Extension of Time to File for Protective Measures"

filed confidentially on 29 July 2008 ("Motion"), wherein the Defence for Milan Lukić ("Defence")

requested an extension of the deadline for the filing of further submissions regarding protective

measures for certain identified Defence witnesses until 22 August 2008;<sup>1</sup>

RECALLING that, on 23 July 2008, the Defence was ordered to file its submissions by Friday

8 August 2008;<sup>2</sup>

NOTING that the request was timely filed 11 days prior to the expiry of the 8 August 2008

deadline;

NOTING the Defence assertion that due to the fact that "investigations with any real meaning were

impossible to undertake" as a result of multiple Counsel changes and the assignment of an

investigator only shortly before the trial proceedings started, the Defence was not able to provide

the Trial Chamber with adequate information regarding protective measures;<sup>3</sup>

NOTING the Defence's submission that the extension is necessary because re-contacting all the

Defence witnesses within a short period of time is a challenging task which requires further

travelling and investigations;<sup>4</sup>

CONSIDERING that it is in the interests of justice, where practicable, to allow parties seeking

protective measures for witnesses sufficient time to obtain and submit detailed information in

support of the request for such measures;

PURSUANT to Rules 54 and 127 of the Rules of Procedure and Evidence of the Tribunal;

**HEREBY GRANTS** the Motion and

ORDERS the Defence to file its submissions regarding protective measures for the witnesses

identified in the Motion, no later than Friday 22 August 2008.
