**THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "Tribunal", respectively),

**BEING SEISED OF** the appeals lodged by Nikola Šainović, Dragoljub Ojdanić, Nebojša Pavković, Vladimir Lazarević, Sreten Lukić, and the Office of the Prosecutor against the Judgement rendered in this case by Trial Chamber III on 26 February 2009;

**CONSIDERING** that the filing of the briefs in these appeals is complete;

**NOTING** that Rule 114 of the Rules of Procedure and Evidence of the Tribunal provides that "[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties";

**HEREBY ORDERS** that the hearing of the appeals in the present case shall take place on 11-15 March 2013, and 18-19 March 2013 in Courtroom III; and

**INFORMS** the parties that a timetable for the hearing will be provided in due course and that other modalities of the hearing, including questions the parties will be invited to address, will be specified by further order.
