

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of “Sreten Lukic’s Sixth Motion to amend Rule 65 *ter* Exhibit List with Annex A,” filed on 6 March 2008 (“Motion”), and hereby issues this decision thereon.

1. In the Motion, the Lukić Defence seeks to add one document, numbered 6D1531, to its Rule 65 *ter* exhibit list,¹ on the basis that it received that document from the National Council for Cooperation with the ICTY on 25 February 2008. The Defence emphasises that the document is relevant to the trial, indispensable for the presentation of the defence case, and that its addition to the list would serve the interests of justice.
2. The Prosecution has indicated that it does not intend to respond to the Motion.
3. The Chamber notes that the document is currently pending translation. The Lukić Defence is reminded that it must provide an English translation of this document for it to be tendered as evidence in the case.
4. Accordingly, the Trial Chamber, pursuant to Rules 54 and 65 *ter* of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion.
