I, CARMEL AGIUS, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING the “Decision on Urgent Defence Motion for Provisional Release,” filed confidentially on 12 May 2017 by the Trial Chamber seised of *Prosecutor v. Ratko Mladić*, Case No. IT-09-92-T, which denied Mr. Ratko Mladić’s motion for provisional release;¹

NOTING the “Interlocutory Appeal of Mr. Ratko Mladić Against Trial Chamber’s Decision on Emergency and Urgent Motion for Provisional Release of Mr. Ratko Mladić Based on Humanitarian and Medical Reasons Dated 12 May 2017”, filed confidentially on 19 May 2017 (“Interlocutory Appeal”), pursuant to Rule 65(D) of the Rules of Procedure and Evidence of the Tribunal (“Rules”);²

CONSIDERING Articles 12, 13 *quinquies*, and 14 of the Statute of the Tribunal and Rule 65(D) of the Rules;

CONSIDERING that Rule 19(A) of the Rules authorises the President to co-ordinate the work of the Chambers;

CONSIDERING the composition of the Appeals Chamber of the Tribunal set out in document IT/263/Rev.13, issued on 6 October 2016;

CONSIDERING the appeal management and case distribution needs of the Tribunal;

HEREBY ORDER that the Bench in *Prosecutor v. Ratko Mladić*, Case No. IT-09-92-AR65.1, shall be composed as follows:
