SCHEDULING ORDER FOR RULE 65 *TER* MEETINGS AND STATUS CONFERENCES AND DECISION ON DEADLINE FOR RULE 68 (i) DISCLOSURE

**TRIAL CHAMBER I** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

**NOTING** that the Initial Appearance and the Further Appearance in the present case were held on 3 June 2011 and 4 July 2011, respectively, and that the First Rule 65 *ter* Meeting and the First Status Conference were held on 18 August 2011 and 25 August 2011, respectively;

**NOTING** that, at the First Status Conference, the Chamber scheduled the Second Rule 65 *ter* Meeting and the Second Status Conference for 3 October 2011 and 6 October 2011, respectively;<sup>1</sup>

**NOTING** that, at the First Status Conference, the parties were instructed to file the first progress report on agreed facts on 19 September 2011 and subsequent progress reports one week prior to each Rule 65 *ter* meeting;<sup>2</sup>

**CONSIDERING** Rule 65 *bis* (A) of the Rules which provides that a Trial Chamber shall convene a status conference within 120 days of the last status conference;

**CONSIDERING** the Prosecution's submissions of 25 August 2011 concerning a deadline for Rule 68 (i) disclosure;<sup>3</sup>

PURSUANT TO Rules 54 and 65 bis, 65 ter, and 68 of the Rules;

**HEREBY SCHEDULES** Rule 65 *ter* meetings for 8 November 2011, 5 December 2011, 16 January 2012, and 20 February 2012, and status conferences for 10 November 2011, 8 December 2011, 19 January 2012, and 23 February 2012 (times and venues to be communicated by the Registry at a later stage);

**DECIDES** that the Prosecution should complete any Rule 68 (i) disclosure by 15 November 2011 and that it should file a notice to this effect.
