TRIAL CHAMBER I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Chamber”);

NOTING its scheduling order of 13 January 2014 (“Scheduling Order”);¹

NOTING its inclination expressed on 3 December 2013 that the Defence case, if any, should commence on 13 May 2014;²

NOTING the Defence’s acceptance in relation to this commencement date;³

NOTING the Prosecution’s submission of 24 February 2014, wherein it rested its case;⁴

HEREBY CLOSES the Prosecution’s case;⁵

ORDERS that any Rule 98 *bis* submissions shall be heard on 17-19 March 2014;

REMINDS the Defence that in accordance with the Scheduling Order, Dragan Ivetić (a member of the Mladić Defence team) may present the Defence’s oral Rule 98 *bis* submissions in court in the absence of counsel and be present in court (in the absence of counsel) for the Chamber’s delivery of its Rule 98 *bis* decision or judgement only if the Accused files his consent for this prior to 17 March 2014;

FOR THE FOREGOING REASONS

ORDERS as follows, in the event there is a need for a Defence case:

- 1) the Defence shall file its witness and exhibit lists pursuant to Rule 65 *ter* (G) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) not any later than 28 April 2014;
- 2) the Defence shall perform its disclosure obligations pursuant to Rule 67 (A) of the Rules no later than 5 May 2014;
- 3) the Pre-Defence Conference pursuant to Rule 73 *ter* of the Rules shall be held on 12 May 2014;


