I, PATRICK ROBINSON, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal").

NOTING the "Order Assigning Judges to a Case Before a Trial Chamber", issued 30 June 2006, ordering that Judge O-Gon Kwon shall be assigned to the Bench in Prosecutor v. Popović et al., Case No. IT-05-88;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President of the International Tribunal to coordinate the work of the Chambers;

CONSIDERING the composition of the Trial Chambers of the International Tribunal as set out in document IT/266 issued on 2 September 2009, which reassigned Judge O-Gon Kwon to Trial Chamber III;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY ORDER that Judge O-Gon Kwon remains a Judge of Trial Chamber II for purposes of Prosecutor v. Popović et al., Case No. IT-05-88, pending any further order.
