NOTING the Decision on Validity of Appeal of Vojislav Šešelj Challenging Jurisdiction and Form of Indictment, issued by the three-judge bench of the Appeals Chamber on 29 July 2004, declaring the appeal to be validly filed;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal set out in Document IT/222 of the International Tribunal, dated 17 November 2003;


