TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

PROPRIO MOTU.

CONSIDERING that Vojislav Šešelj ("Accused") was hospitalised on 6 January 2012 and still remains in hospital,

CONSIDERING that since the last hearing on 23 August 2011¹ until the day of his hospitalisation, the Chamber was not informed about the state of heath of the Accused,

CONSIDERING that the Chamber, concerned by the state of health of the Accused, deems that it is necessary to obtain precise information on the circumstances of the hospitalisation and the current health of the Accused,

CONSIDERING that there is need for the Accused to undergo a medical examination,

CONSIDERING that Dr Sergei Nickolaevitch Avdeev has already been part of the medical expert team charged with examining the Accused in 2011² and is, therefore, familiar with the medical file of the Accused,

CONSIDERING that Dr Sergei Nickolaevitch Avdeev, Pulmonary Specialist, could, should the need arise, be offered assistance from other physicians specialising in the illness from which the Accused is suffering,

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 74 *bis* of the Rules of Procedure and Evidence of the Tribunal.

ORDERS the Registry:

- to obtain as soon as possible, and within a maximum of five days from the date

of this order, a report from the Commanding Officer of the United Nations

Detention Unit ("Detention Unit") on the circumstances under which the

Accused was hospitalised and the procedure followed by the personnel

involved,

- to obtain as soon as possible, and within three days of the date the Accused

returns to the Detention Unit, a detailed medical report from the Detention Unit

physician on the state of health of the Accused,

- to appoint, subject to availability, Dr Sergei Nickolaevitch Avdeev, as a

specialist physician and to provide, as soon as possible and within 30 days at the

latest from the date of the return of the Accused to the Detention Unit, his

detailed report on the state of health of the Accused,

- to appoint, should Dr Sergei Nickolaevitch Avdeev be unavailable, another

physician of the same nationality, who specialises in the illness of the Accused,

- to authorise, if need be, Dr Sergei Nickolaevitch Avdeev to engage the

services of another physician.
