#### **PUBLIC REDACTED VERSION OF SECOND DECISION ON PROSECUTION'S MOTION UNDER RULE 77 CONCERNING FURTHER BREACHES OF PROTECTIVE MEASURES (THREE BOOKS) ISSUED ON 3 FEBRUARY 2010**

On 4 February 2010, the Trial Chamber initiated contempt proceedings against Vojislav Šešelj for having disclosed information which might identify 11 protected witnesses in violation of orders of a Chamber, and issued an order in lieu of an indictment on one count of contempt of the Tribunal. The Chamber directed the Registrar to appoint an *amicus curiae* prosecutor to prosecute the charge and declared that at a time to be

determined the accused should appear before the Chamber to enter a plea – *See Press Release number 1345, dated 5 February 2010.*
