DECISION ON REQUEST FOR REVIEW OF OLAD DECISION ON TRIAL PHASE REMUNERATION *

On 19 February 2010, Judge Robinson granted in part the request by Karadžić and ordered the Registrar to allocate to the accused's Defence team 1,200 remunerable hours

per month until the resumption of the trial, 750 remunerable hours per month during the trial, and to remunerate Peter Robinson at a rate of 71 euros per hour during the trial.

DECISION ON THE ACCUSED'S MOTION FOR POSTPONEMENT OF TRIAL

On 26 February 2010, the Chamber denied the motion by Karadžić and ordered that the accused's opening statement shall be heard on 1 and 2 March, following which the trial proceedings will continue on 3 March 2010 with the hearing of evidence. During the opening statement, Richard Harvey shall be present in the courtroom and may be accompanied by up to two members of his team but his role in the further trial proceedings is yet to be determined.
