DECISION

On 2 March 2010, the Deputy Registrar decided to appoint Bruce MacFarlane as *amicus curiae* to prosecute the alleged knowing and wilful disclosure of information in violation of an order of a Chamber by Vojislav Šešelj (*contempt case number IT-03-67.R77.3*).

ORDER WARNING LAHI BRAHIMAJ TO ADHERE TO THE TERMS OF HIS PROVISIONAL RELEASE

On 4 March 2010, the Appeals Chamber reminded Lahi Brahimaj that he was under judicial order of the Tribunal to adhere strictly to the terms of his provisional release. The Chamber warned Brahimaj that his release will be terminated in the event that he fails to comply with any instruction of the authorities of the EULEX-Kosovo Mission necessary to enable it to comply with its obligations in relation to his provisional release.

This order followed a report by the EULEX-Kosovo Mission, dated 19 February 2010, stating that Brahimaj failed to appear at a pre-arranged weekly meeting at his residence.
