SCHEDULING ORDER FOR HEARING REGARDING VESELIN ŠLJIVANČANIN'S APPLICATION FOR REVIEW

On 20 April 2010, the Appeals Chamber found, Judge Pocar dissenting, that it would be in the interest of justice to convene a hearing to examine legal and evidentiary aspects of Veselin Šljivančanin's application for review of the appeal judgement. The application asserted that Miodrag Panić was prepared to offer testimony that would invalidate the Šljivančanin's conviction for aiding and abetting murder as a violation of the laws and customs of war and that his testimony would constitute a new fact in the context of Rule 119 of the Rules of Procedure and Evidence. The Chamber ordered that the hearing be held on 3 June 2010 at 09:00 in a courtroom to be determined.
