**MOTION TO AMEND THE AMENDED INDICTMENT AND FOR ORDERS
UNDER RULES 53(A), 55 AND 59bis (A)**

On 10 May 2010, the Prosecution filed a motion with a proposed amended indictment against Ratko Mladić. According to the motion, the proposed indictment “*clarifies and further specifies the Prosecution’s allegations against the accused and updates the legal and factual pleadings in the operative indictment.*”

DECISION ON ČERMAK AND MARKAČ DEFENCE REQUESTS FOR CERTIFICATION TO APPEAL THE TRIAL CHAMBER DECISION OF 21 APRIL 2010 TO REOPEN THE PROSECUTION'S CASE

DECISION OF PRESIDENT ON APPLICATION FOR PARDON OR COMMUTATION OF SENTENCE OF DARIO KORDIĆ

On 13 May 2010, Judge Robinson denied early release for Dario Kordić concluding, *inter alia*, that “*the fact that Mr Kordić has demonstrated some rehabilitation is outweighed by the very high gravity of his crimes and, taking into account the treatment of similarly situated prisoners, the amount of time that he has served for those crimes.*”
