TOLIMIR case

Trial Chamber II – Judges Flügge (President), Mindua and Nyambe

DECISION ON ZDRAVKO TOLIMIR'S SUBMISSION CONCERNING THE POSSIBLE TRIAL SCHEDULE FOR JUNE

On 27 May 2010, the Trial Chamber denied in part the motion by the accused and ordered that the trial would sit on three days each week until the summer recess (*Tolimir asked for the continuation of the current practice of sitting two days a week*).

ORDER ISSUING A PUBLIC REDACTED VERSION OF THE “DECISION ON ACCUSED’S REQUEST TO THE TRIAL CHAMBER CONCERNING ASSISTANCE OF HIS LEGAL ADVISOR”

On 27 May 2010, the Trial Chamber issued a public redacted version of its decision from 28 April 2010, in which the accused’s motion was granted in part and decided that during the trial, Aleksandar Gajić, acting in the capacity of Tolimir’s legal adviser, would have a right of audience limited to:

- addressing the Chamber on legal issues that arise during the proceedings, upon a specific request for such by the accused being granted by the Chamber;
- addressing the Chamber on administrative issues arising out of Gajić’s correspondence with the Prosecution and relating to the conduct of the proceedings.
