GOTOVINA et al. case

Trial Chamber I – Judges Orié (President), Ķinis and Gwaunza

DECISION ON THE GOTOVINA DEFENCE'S REQUEST TO ORDER THE EUROPEAN UNION TO CARRY OUT FURTHER INVESTIGATIONS ON THE WHEREABOUTS OF THE "RC KNIN LOG-BOOK"

On 3 June 2010, the Chamber denied the request by the Gotovina's Defence to order the European Union to broaden and intensify its search for the RC Knin Log-book, including by interviewing two former monitors Marker-Hansen and Liborius. The Trial Chamber concluded, *inter alia*, that "the EU has undertaken substantial efforts to locate the RC Knin Log-book, but has been unable to find it, or even confirm its existence. The Gotovina Defence has not pointed to any statements or information, either from the examinations in court or from any possible enquiries carried out by the Gotovina Defence itself, indicating that Liborius and Marker-Hansen would be able to provide further information regarding the existence or whereabouts of the RC Knin Log-book."
