Gojko JANKOVIĆ case

DECISION ON GOJKO JANKOVIĆ'S MOTION OF 12 APRIL 2010

On 21 June 2010, the Referral Bench denied the motion by Gojko Janković to revoke the referral order and return his case to the Tribunal, as well as his request to order the BiH State Court to re-try him on the basis of the Tribunal's original indictment.

Janković was transferred to the BiH State Court in 2005 and sentenced there to 34 years' on 19 November 2007.

DECISION ON JOINT MOTION FOR EXTENSION OF TIME TO FILE NOTICE OF APPEAL
