DECISION ON DRAGOLJUB OJDANIĆ'S MOTION FOR TEMPORARY PROVISIONAL RELEASE ON COMPASSIONATE GROUNDS

On 9 August 2010, Judge Meron granted the motion by Dragoljub Ojdanić for provisional release on compassionate grounds and ordered that his release would commence on 19 August 2010 (or as soon thereafter as practicable) and would last for not more than five days from the release date.

DECISION ON ACCUSED'S MOTION FOR SUSPENSION OF PROCEEDINGS

On 18 August 2010, the Trial Chamber granted Karadžić's motion in part and ordered that after the completion of the testimonies of Richard Higgs and Tomasz Blaszczyk the trial would be suspended for two weeks.

Karadžić asked for the suspension in order to allow him and his Defence team to review the disclosed cassettes and CDs seized during the last search of Ratko Mladić's house in Belgrade.
