Initial appearance

On 10 October 2011, the parties met before Judge Flügge for the initial appearance of Dragomir Pećanac, charged with contempt for failing to comply with a subpoena in which he was ordered to testify in the Tolimir case. The accused chose not to enter a plea – *See Press Release number 1449, dated 10 October 2011.*

DECISION ON CONSOLIDATED PROSECUTION MOTION TO SEVER THE INDICTMENT, TO CONDUCT SEPARATE TRIALS, AND TO AMEND THE INDICTMENT

On 13 October 2011, the Chamber denied the Prosecution's request to sever the indictment against Mladić but granted the motion to amend the current indictment – *See Press Release number 1451, dated 13 October 2011.*
