MLADIĆ Case

Trial Chamber I – Judges Orić (Presiding), Moloto and Flüggé

ORDER FOR A MEDICAL EXAMINATION OF THE ACCUSED PURSUANT TO RULE 74bis

On 16 November 2011, the Chamber ordered the Registry to facilitate a complete medical examination of the accused and to file a report confidentially no later than 6 December 2011 – *See Press Release number 1462, dated 16 November 2011.*

GOTOVINA&MARKAČ Case

Appeals Chamber – Judges Meron (Presiding), Güney, Pocar, Vaz and Agius

DECISION ON ANTE GOTOVINA'S RENEWED APPLICATION FOR AN ORDER PURSUANT TO RULE 54bis DIRECTING THE GOVERNMENT OF THE REPUBLIC OF SERBIA TO PRODUCE DOCUMENTS

On 16 November 2011, the Chamber denied Gotovina's application for an order to direct Serbia to produce documents (relating to, *inter alia*, to the departure of Serb civilians from the Krajina region in August 1995).

HARTMANN Case ("Contempt")

Appeals Chamber – Judges Robinson (Presiding), Vaz, Meron, Hall and Morrison

SECOND ORDER ON PAYMENT OF FINE PURSUANT TO RULE 77bis AND WARRANT OF ARREST

On 16 November 2011, the Chamber found that the first and second installments of the fine had not been paid by Hartmann within the time specified and therefore converted the whole of the fine to a term of seven days of imprisonment. Subsequently, the French Republic was directed to search for, arrest, detain and surrender Hartmann promptly to the Tribunal.

Jelena RAŠIĆ Case ("Contempt")

Trial Chamber III – Judges Morrison (Presiding), Hall and Delvoie

AMENDED SCHEDULING ORDER AND ORDER TERMINATING PROVISIONAL RELEASE

On 18 November 2011, the Chamber ordered that the pre-trial conference should be held on 23 January 2012, to be followed by the commencement of trial. The accused is ordered to return to the UN Detention Unit by 20 January 2012.
